**RISK OF LOSS.**

All risk of loss for the use and care of the Equipment shall be with Lessee from the time of delivery by Party Rent DFW, and shall remain

with Lessee until time of pickup by Party Rent DFW.

**CONDITION OF EQUIPMENT**

Lessee shall be fully and solely responsible for the condition of the Equipment at all times from the date of delivery through the date of

pickup by Party Rent DFW. All Equipment shall be returned to Party Rent DFW in the same condition and repair as when leased, ordinary

wear and tear only accepted. Lessee is responsible for all damage, repair, loss or cost to the Equipment or any part of the Equipment. If any

Equipment is returned damaged or if there is a failure to return any part of the Equipment, Lessee shall be billed for the cost of the repair

to or replacement of the Equipment and Lessee agrees to pay for the same upon demand by Party Rent DFW.

**CARE OF EQUIPMENT**

All payments are non-refundable. No changes are allowed after 14 days prior to your delivery date unless approved by Party Rent DFW Management. All equipment must be stacked or placed in containers provided as delivered. Additional charges will

be applied if items are not stacked and placed in containers. Leaving equipment exposed to the rain will damage the equipment and replacement charges will be accessed. Do not place wet linens in plastic bags as they will mildew.

Replacement charges will be accessed.
